I have been nominated in 2007 to be the "Haut représentant du Gouvernement français pour l'accueil de ITER en France". My mission is to coordinate all the French administrations, at the ministerial level, to facilitate the implementation of the ITER Organization and ITER program in Cadarache (France). CEA is the channel by wich France will contribute financially (over 1.2 billions of euro) to the construction of the ITER facility.
