# VACANCY NOTICE FOR A TRAINEESHIP

# **1. DESCRIPTION OF THE DEPARTMENT/PROJECT UNIT**

Fusion for Energy, or F4E, a European Union Joint Undertaking, headquartered in Barcelona, specifies and manages the production of the European contribution (45%) to ITER. This research fusion reactor in Cadarache, France, will progress fusion by a major leap towards clean and sustainable generation of abundant base load energy, complementing renewables.

ITER is one of the largest construction projects in Europe and the world's largest scientific partnership. ITER brings together seven parties that represent half of the world's population – the EU, Russia, Japan, China, India, South Korea and the United States.

The Legal Services Unit of Fusion for Energy is a diverse team that fosters an environment of creativity and innovation. We define and create enabling frameworks for first-of-a-kind and one-of-a-kind business operations that must comply with stringent requirements in a technically and legally complex environment.

In particular, the Legal Service Unit provides legal support and advice on all legal matters related to the functioning of F4E and has the following corporate legal responsibilities:

- To provide legal advice on F4E statutory, governance and other corporate legal issues including review of documents for submission to internal and external bodies;
- To provide legal advice related to the administrative and operational management of F4E including drafting of relevant F4E internal rules, guidance and processes;
- To draft and negotiate international and inter-institutional agreements and arrangements including agreements with the Host State(s), the IO-CT and the Commission;
- To provide the secretariat of the Administration and Management Committee (AMC);
- To provide the secretariat of the Procurement and Contract Committee (PCC), the PCC Preparatory Panel;
- To draft and review procedures and templates related to procurement and grant procedures and to F4E activities that have legal or contractual character;

- To draft and update the models for procurement contracts and grants agreements and ensuring the follow up of its appropriateness;
- To provide legal advice in relation to the drafting, application and interpretation of F4E Financial Regulation, and its implementing rules and coordination of their revisions;
- To provide legal advice on staff matters including drafting and review of guidance documents, implementing rules and of decisions or replies to requests and complaints;
- To provide legal advice on export-control matters;
- To provide legal advice on health and safety matters;
- To provide legal advice on application of PPI and host country legal matters;
- To managing legal disputes related to general and staff matters in front of the national authorities, courts and Court of Justice of the European Union (CJEU);
- To provide legal advice on enquiries by the European Ombudsman;
- To act as F4E contact point and representation in the Inter-Agency Legal Network.

The Legal Service Unit provides project legal support on all legal matters related to the F4E procurements and contracts implementation, in particular:

- To support the preparation, negotiations and conclusion of the Procurement Arrangements;
- To provide legal support to the whole of F4E on procurement strategies, preparation, launch, negotiations and signature of procurement contracts and grant agreements;
- To draft operational contracts;
- To review the award of contracts and grants submitted to the Preparatory PCC and Internal Review Panel;
- To provide legal support in follow up of the contracts including their interpretation, negotiation, amendments, suspension or termination or claims arising during contract and grant implementation;
- To provide legal advice in establishment and implementation of the global transportation scheme;
- To manage claims and pre-litigation dispute settlements related to contracts implementation, in particular through mediation;
- To manage legal disputes related to contracts and procurement in front of adjudication boards, the national courts and CJEU;
- To develop and coordinate F4E's insurance policies;
- To manage requests of access to documents regarding procurement procedures.

# 2. DESCRIPTION OF TASKS

The Legal Trainee will be part of a multi-cultural and collaborative team of legal practitioners.

The successful candidate may in particular be required to carry out the following corporate legal tasks:

- Assisting in corporate legal matters arising within the context of the various legislative acts governing Fusion for Energy's (F4E) activities;
- Assisting on legal issues regarding Human Resources (HR), based on EU Staff Regulations (e.g. implementation of staff rules or particular HR questions);

- Contributing to prepare and hold Internal Review meetings regarding contract award;
- Providing assistance with respect to questions of Data Protection;
- Assisting in providing legal advice related to F4E internal rules and processes;
- Assisting in providing legal advice related to agreements with other bodies.

The trainee may in particular be required to carry out the following project legal tasks:

- Assisting in F4E Project related legal matters regarding public procurement;
- Assisting to provide legal support to Project Teams with respect to the procurement strategies and preparation of tender procedures and procurement contracts;
- Contributing to legal review of tender procedures and contract follow-up in respective fields (Grants and Procurements);
- Assisting in legal review of specific Construction related tender procedures and Contracts (FIDIC);
- Contributing to work regarding an Adjudication Panel;
- Assisting on insurance and health/safety related legal issues.

The trainee may also be required to carry out the following general legal tasks:

- Reviewing templates of tender procedure and modal contracts (Grants and Procurement);
- Assisting to legal matters related to the F4E Financial Regulation and its Implementing Rules
- Participation in LSU related meetings and taking minutes;
- Research and knowledge-sharing work in upcoming F4E legal matters (e.g. case-law of the ECJ on public procurement);
- Assessing (EU) Case law in respective areas;
- Analysing arising Spanish law issues;
- Provide support and assist the members of the respective group when required upon the agreement of the Trainee's supervisor.

# **3.** ELIGIBILITY CONDITIONS

- Be a national of one of the Member States of the European Union or of a Third state fully associated with the Euratom fusion programme (Switzerland);
- The candidate must have finished his/her university degree of at least 3 years attested by a diploma. The university degree must have been obtained within the last 3 years before the closing date for applications;
- In order for the trainee to fully profit from the traineeship and to be able to follow meetings and perform adequately, candidates must have good knowledge of English, the main working language of F4E.

Applications will not be accepted from candidates who:

- have already benefited from any kind of in-service training within a European institution or body, or
- who have had or have any kind of employment within a European institution or body.

## 4. QUALIFICATIONS REQUIRED

- University degree in Law;
- Good knowledge of EU law, contract law and exposure to Public procurement law
- Excellent command of written and oral English;
- Good analytical capabilities;
- Knowledge of other languages is as asset (in particular French);
- Excellent computer literacy (MS Word);
- High motivation, willingness to commit, adaptability to international and multicultural environment.

## 5. WHAT WE OFFER

Trainees are awarded a monthly maintenance allowance. The monthly allowance for 2019 amounts to  $\notin$  1.097,50 (Spain).

Additionally, trainees may receive a travel allowance, subject to budget availability, to compensate for travel expenses incurred from the place of residence to the seat of F4E and vice versa. Trainees whose place of recruitment is less than 50 km from F4E's offices shall not be entitled to a travel allowance.

A motivation letter of 2 pages maximum in English
