## DECISION OF THE GOVERNING BOARD ADOPTING THE FIRST AMENDMENT TO THE 2017 BUDGET OF THE EUROPEAN JOINT UNDERTAKING FOR ITER AND THE DEVELOPMENT OF FUSION ENERGY

THE GOVERNING BOARD OF FUSION FOR ENERGY,

HAVING REGARD to the Statutes annexed to the Council Decision (Euratom) No 198/2007 of 27 March 2007 establishing the European Joint Undertaking for ITER and the Development of Fusion Energy (hereinafter "Fusion for Energy") and conferring advantages upon it<sup>3</sup> (hereinafter "the Statutes") and in particular Article 6(3)(e) thereof, amended on 10 February 2015 with Council Decision Euratom 2015/224<sup>4</sup>;

HAVING REGARD to Council Decision N° 791/2013 of 13 December 2013 amending decision 2007/198/EURATOM establishing the European Joint Undertaking for ITER and the Development of Fusion Energy and conferring advantages upon it<sup>5</sup>;

HAVING REGARD to the Financial Regulation of Fusion for Energy<sup>6</sup> adopted by the Governing Board on 2 December 2015<sup>7</sup> (hereinafter "the Financial Regulation"), and in particular Title III thereof;

HAVING REGARD to the Implementing Rules of the Financial Regulation<sup>8</sup> adopted by the Governing Board on 2 December 2015<sup>9</sup> (hereinafter "the Implementing Rules"), and in particular Title III thereof;

HAVING REGARD to the 2017 Work Programme adopted by the Governing Board on 21 February 2017<sup>10</sup> and to its amendment adopted on 4 July 2017;

HAVING REGARD to the 2017 Budget adopted by the Governing Board on 21 February 2017<sup>11</sup>;

HAVING REGARD to the EU 2017 General Budget adopted on 28 February 2017<sup>12</sup>;

HAVING REGARD to the opinions and recommendations of the Administration and Management Committee on the proposal for the first amendment to the 2017 Budget at their meeting of 6-7 June 2017<sup>13</sup>.

WHEREAS:

- (1) The Director should, in accordance with Article 8(4)(e) of the Statutes, draw up the annual budget;
- (2) The Administrative and Finance Committee should, in accordance with the mandate described in its Rules of Procedure, comment on and make recommendations to the Governing Board on the proposal for the annual budget drawn up by the Director;
- (3) The Governing Board should adopt the annual budget which becomes definitive after final adoption of the general budget setting the amount of the Community contribution and the Establishment plan;

HAS ADOPTED THIS DECISION:

Article 1

The first amendment to the 2017 Budget of Fusion for Energy annexed to this Decision is hereby adopted.

## Article 2

The payment appropriations in the 2017 Budget shall be automatically increased by a maximum of EUR 267 million, if necessary by instalments, subject to confirmation of the exact amount by Euratom.

The increase of Euratom's contribution shall be allocated to chapter 31 "ITER construction including the ITER site preparation" of the 2017 budget of Fusion for Energy. Each allocation shall constitute a formal amendment to the 2017 Budget of Fusion for Energy within the limit of EUR 267 million.

Each time the payment appropriation budget is increased, the Governing Board will be informed.

Article 3

The conversion of short term to long term positions for 1 TA AD6 and 2 CA FG IV is hereby endorsed.

Article 4

This Decision shall have immediate effect.
