Possible additional Allowances and benefits

Family allowances

Household allowance: 234.18€ plus 2% of the basic salary

Dependent child allowance: 511.71€

Education allowance, where appropriate, up to 347.20€ per child (can be doubled in some cases)

Preschool allowance: 125.01€ per child

Allowances (subject to personal circumstances)

Where appropriate - Expatriation allowance (16% of the basic salary - minimum 686.16 €) Foreign-residence allowance (4% of the basic salary).

Deductions

Pension and insurance contribution

Pension rights: 12.1% of the basic salary
Health insurance: 1.70% of the basic salary
Accident insurance: 0.10% of the basic salary
Unemployment: up to 0.51% of the basic salary

Community taxation

Salaries are exempt from national income tax but subject to tax to the benefit of the European Union. Salary is subject to correction coefficients and adjustments, which vary according to the living conditions in the place of employment, and are revised on an annual basis.

The current correction coefficient for Spain is 92.3%, for France is 114.2% and for Germany (Munich) 113%
